### Anjali Van Drie, MA, MSW, BCBA



# **Our Three Tier Model of Support**

Family Initiative, Inc. uses a blend of Applied Behavior Analysis and Trust Based Relational Intervention to provide three different levels of support to caregivers\*:

#### 1. Pre-Service Training Class:

Family Initiative staff partners with licensing agencies to enhance the training regarding behavior management and discipline during the initial licensing process. Our staff will cotrain a class during the initial licensing training.

#### 2. In-Service Training Course:


Our clinicians provide a 9 hour course to provide hands on, real time behavioral tools and recommendations for licensed families to use with the children in their home. It's recommended caregivers enroll in this class soon after their firs placement.

#### 3. In Home Intensive Support:

Our high quality clinicians are available to come to into the home to provide individualized, intensive support to families having difficulty managingbehaviors of a child in the home. We provide tailored recommen dations to each home to assist in stabilizing the placement.



\* Participation in Tier 1 and 2 training is not required for in home support.



Our trainings feature tools and techniques for families to begin using when they walk out the door!

## How to Get Involved:

### **Pre-Service Training:**

No additional requirements are necessary to take part in the Tier 1 training. This will be provided as part of the training every licensed caregiver completes.

#### **In-Service Training:**

Families interested in participating in the 9 hours course should contact their placement worker or licensing specialist. Class size is limited to 16 participants but will be provided at various locations across the Circuit.

#### In-Home Intensive Support:
